2	4.4 QMS and its Processes (4.4.2)	Maintain (1) documented information (documented procedure) to support Process performance and retain (2) documented information (records) to ensure planned Process implementation (control).	 QSP describing implementation of QMS Processes (system-processes), detailed enough to be implemented (sec.4.4) + training; 'Quality Manual' sections that describe the relationship of the QMS processes required by this Standard. Databases, logs of process control criteria monitoring results Meeting Minutes on analysis of process performance
